I. CALL TO ORDER

- **a.** A regular meeting of the Board of Directors of the West Park Jr. Panthers was duly called on Monday, April 4, 2022, at 6:36 PM. Ricky Arbolante, President, called the meeting to order. A quorum was declared present based on the presence of the individuals listed above.

II. OLD BUSINESS

a. All board members now have access to their email addresses. The website will be updated accordingly.

III. NEW BUSINESS

- a. The board discussed options on how to proceed with the 10U and 12U football roster sizes. After much discussion the board voted and approved to reduce rosters to 40 athletes. A football clinic will be held in the coming weeks to evaluate players and inform families of those athletes who we are unable to accommodate this year, allowing them ample time to find another program.
- **b.** The board briefly discussed our options for increasing our capacity in the coming years to be able to accommodate more players with our growing community.
- **c.** The board voted and approved the purchase of 30 new football equipment sets and uniforms to accommodate our roster sizes. This number includes the 10 sets previously approved at the January 11, 2022 meeting.
- **d.** The board also voted and approved the purchase of game and practice footballs as the will no longer be purchased through SYF.

IV. REPORTS

- a. Ricky Arbolante:
 - i. SYF updates:
 - **1.** SYF should have their divisions completed in April.
 - 2. Currently SYF plans on having 6 divisions with 9 programs each.
 - **3.** There will be "crossover games" playing an opponent in a different division. This will possibly have the option to travel to Chico or Reno.
 - **4.** The rule book has been updated and posted. This does include some changes to fees and footballs will now be purchased by programs rather than through the league.
- **b.** Stephanie Whittington:
 - i. Cheer evaluations need to be held to place athletes on the appropriate team for their skill level. Hopefully, these can be held at the same time as the football clinic.
 - ii. 8U registration will be closed due to the number of athletes registered.
 - iii. Mascot registration will close once 22 athletes are registered.
 - iv. Stephanie discussed the option of a stunt team in the spring 2023.
 - 1. Season is from February 1 May 31
 - **2.** Teams are 8U, 11U and 14U
 - **3.** Fees to the program are \$399 plus \$30/coach and \$25/athlete
 - **4.** It is reported that other programs in our area will be competing

 - i. Troy discussed the current equipment numbers and needs.

 - i. Updated the board on account balances and outstanding payments.
