


# SCHOOL ENROLLMENT VERIFICATION INSTRUCTIONS


School enrollment verification must include 1). **child's name**, 2). **date of birth**, 3). **grade (in the Fall)** and 4). **address**. If you are unable to obtain the school enrollment form, the information can be listed on school letterhead or the school can stamp and sign a document with the information.

Roseville City School District uses PowerSchool. Below are the PowerSchool instructions to view/print your child's school enrollment form.


1. Sign into the Roseville City School District PowerSchool Parent Portal at <https://rcsdk8.powerschool.com/public/home.html>




2. Under the **Navigation** section, click **Registration**.

4. Scroll down to **Print a copy for your records** and click the **Student Registration** link. This will open a pdf of the school enrollment form.
