## I. CALL TO ORDER

**a.** A regular meeting of the Board of Directors of the West Park Jr. Panthers was duly called on Monday, August 14, 2023, at 6:28 PM. Ricky Arbolante, President, called the meeting to order. A quorum was declared present based on the presence of the individuals listed above.

## II. OLD BUSINESS

- a. Poll to approve refund, less spirit pack and uniform, for 8u cheerleader Approved 7/19/23 (11-4)
- b. Poll to approve new registration for 8u gold team cheerleader Approved 7/24/23 (13-4)
- **c.** Amanda D'Amico resigned from her position as Football Medical Coordinator.

## III. NEW BUSINESS

- **a.** Jorge Silva has been elected, effective immediately, as the Football Medical Coordinator.
- **b.** The board approved the purchase of weights and bungee cords to secure our pop-up tents.
- **c.** The board discussed and agreed that free entry for players only applies to players in uniform scheduled to play at West Park that day. It does not apply to players from other teams who come to watch the game.

## IV. REPORTS

- **a.** Ricky Arbolante:
  - i. SYF President meeting updates:
    - **1.** Championship teams will receive banners and trophies. Runners up will only receive a trophy.
    - 2. Head coaches are the only people who are permitted to talk to the referees.
    - **3.** Referees will be permitted to warn fans/families before ejecting them from a game.
  - ii. Ricky will send our welcome letter to Christian Brothers as soon as possible.
  - iii. Ricky has worked with the high school to enable Panther of the week to be present on the sideline of a WPHS home game. They will be able to run through the tunnel with the team, visit the locker room and watch the game from the sideline. As of now, this only applies to football. Ricky will look at options for cheer athletes as well.
- **b.** Troy Tickle:
  - i. WPHS has requested that we cancel practice Thursday 8/15 for their back-to-school night.
  - **ii.** Team mom emails will include parking reminders and shade tents must be in line with the press box.
  - iii. Any information that needs to go out in team mom emails should be sent before 5 pm on Sunday.
  - iv. Medical Coordinators will be responsible for bringing the med kits on game days.
  - v. Uniforms will be disseminated after practice tomorrow.
  - vi. Lynnette to provide coaches with books on Wednesday for game day.
  - vii. Lynnette to verify X men have the appropriate helmet stickers.
  - viii. Lights to be delivered on Sunday 8/20 and placed the following week.
