a. A regular meeting of the Board of Directors of the West Park Jr. Panthers was duly called on Monday, February 13, 2023, at 6:34 PM. Ricky Arbolante, President, called the meeting to order. A quorum was declared present based on the presence of the individuals listed above.

i. GUESTS

1. No community members were present at this meeting.

II. OLD BUSINESS

a. None

III. NEW BUSINESS

- **a.** The board voted to approve refunds will only be issued until an athlete makes a team after tryouts.
- **b.** Due to the current cheer registration numbers, the board voted to hold tryouts for cheer rather than closing registration.
- **c.** The board voted to approve covering the cost to have at least 1 coach at every level first aid and CPR certified.

IV. REPORTS

a. Ricky Arbolante:

- i. SYF President meeting updates:
 - 1. The schedule should be available mid-April. We have requested a road game on 10/14 as the HS has homecoming that evening.
 - **2.** SYF will provide 1 ball per team. 10 additional balls per team were ordered and should arrive by May.
 - **3.** Gate fees increased to \$6 general admission, \$4 for seniors and children ages 3-11.
 - **4.** Player cards are being updated and will include the athlete's grade. Athletes 12 and under must provide both their birth certificate and school enrollment form. Ricky will see clarification on this at the next meeting.
 - 5. 60 hours of off season training are now permitted by SYF.
- ii. Ricky will register all coaches for Reno.
- iii. Our ORI number should be available by our next meeting.

b. Jewel Grossi:

- ii. Placements are scheduled for 3/28-4/1 from 6: 00 8:00 PM.
- iii. Fittings are scheduled for 4/11 from 4:30 7:00 PM for all teams.
- iv. Branding updates, we are approved to use WP and the Panther head logo on any items.Adding any additional wording or design must be approved.
- **v.** New jackets were approved by the HS. This year athletes will be permitted to wear the new or old version of jackets. Next season (2024) only the new version will be allowed.

d. Ali Browning:

- i. The financial aid form was completed and passed around for members to review.
- **ii.** The Executive Board approved refunding cheer families who did not receive shoes last season the difference between the refund amount that was promised last year and what Varsity is actually refunding. Those refunds have been processed.

e. Vanessa Dela Cruz:

- i. Woodcreek Little League's opening day is 3/11 at 9:00 AM. We have been invited to set up a table
- **ii.** Vanessa proposed holding meet and greet events for board, coaches, team moms and families.
- **iii.** Vanessa also suggested moving our kickoff BBQ to a different location. Once an alternate location is found we will discuss this further.

f. Jason Tenner

- i. Jason proposed fielding two teams at each level next season (2024) to be able to better meet the needs of the community given our overwhelming registration numbers last year and so far this season as well as the continual growth of the area. During the conversation the following issues were brought up:
 - 1. The snack bar can be manned by other clubs/groups at the HS to eliminate the burden of staffing by the Jr program. However, this would generate less revenue for the Jr program.
 - 2. Snack bar storage space is very limited.
 - **3.** The issue of practice space was discussed.
 - **4.** Parking/pickup during HS events was also brought up.
 - **5.** Each board member was asked to consider what support they would need in their position to make this happen and if additional board positions would be required. If so, we could discuss electing members now and training this this season to be more prepared for next season.
